**Please note change of fees for 2025 Snowplow Permits**

**Snowplow Permits: \$40.00 per vehicle**

A Snowplowing Permit is required for persons or firms providing snowplowing services for hire in Unincorporated Ramapo. The fee is \$40.00 per vehicle.

Applicants must provide:

- Proof of valid vehicle registration
- Insurance coverage for all vehicle(s) to be used
- Current driver's licenses for all vehicle operators

**Each Snowplowing Permit is valid for one year; commencing November 15, 2024, and expiring November 14, 2025.** A permit includes a vehicle decal with permit number, license plate number, and expiration date. Decals are to be prominently displayed, affixed to the exterior of each vehicle used for snowplowing services.

Please submit the completed application and associated documents to the Ramapo Town Clerk's office along with the required fee of \$40.00 per vehicle.
