INSTRUCTIONS FOR THE ISSUANCE OF SEWER LICENSES FOR THE TOWN OF RAMAPO

Bond and Certificate of Insurance must be approved by the Town of Ramapo. To obtain such approval, the following must be complied with:

- 1. \$10,000 Surety Bond or Continuation Certificate (with copy of original bond) signed, sealed and notarized, together with Power of Attorney and Profit and Loss statement of bonding company all in acceptable form from a bonding company licensed to do business in New York State.
- 2. Each applicant must obtain from an insurance company licensed to do business in the State of New York, for the benefit of the Town of Ramapo, an insurance certificate indicating coverage for public liability insurance in a general aggregate amount of no less than \$100,000 on account of any one occurrence.
- **3.** Each Certificate of Insurance shall name the Town of Ramapo as insured and insurance must be **Primary to the Town of Ramapo** in the Description of Operations field***.
- **4.** Certificate of Insurance shall contain a provision that the policy and/or bond cannot be cancelled without 30 days prior written notice to the Town of Ramapo. If renewing an existing license, applicant must provide copy of original bond together with continuation certificate.
- **5.** All insurance certificates and surety bonds must cover the calendar year, that is, from January 1st through December 31st. If this requirement or any other requirement is not met, a license will not be issued.
- **6.** Sewer Contractors must be properly licensed with Rockland County.
- **7.** Sewer Contractors must have active status with NYS Department of State Division of Corporations.
